Purpose and activities

Supports and encourages vocal music educators and students through participation in district and state festivals, the Michigan Music Conference and the Michigan Youth Arts Festival. Provides professional development opportunities to its members via clinics, scholarships, its clinician consultant program and its Summer Conference which offers State Continuing Education Clock Hours and to their students through the Student Leadership Conference.



I have always believed that MSVMA is my family...this shows us how deep our support and connection is to one another as we figure out together what the near future holds for vocal music. Adapting for the FY21 School Year

The Board of Directors recognized from an insider's perspective that the 2020-21 school year was a time of uncertainty for schools, students and teachers and wanted to ensure that MSVMA continued to be a valuable resource. The organization's goal was to help every member stay connected to our MSVMA community. The decision was made that whenever feasible, programs and activities traditionally offered would be adapted for students and teachers to continue to participate safely. The following actions were taken to support these goals:

- Due to program and budgetary concerns, school memberships were discounted by 50%. No fee changes were offered for other memberships.
- An assistance program was developed for schools that needed help to participate due to budgetary restrictions that provided \$100 reduction of the discounted school membership fee.

Communications throughout the year reinforced the importance of MSVMA membership to the Michigan's vocal music educators and the benefits that it provides including:

- Access to educational resources including curriculum, an extensive sight-reading library, standard repertoire lists and adjudication rubrics
- Support of a learning community that offers ideas and support regardless of your teaching situation
- Advocacy for members, their programs and music education at the local, state and national levels
- Educational opportunities for members and their students such as The Michigan Music Conference, Student Leadership Conference, Opportunities for members to become an MSVMA adjudicator, the Carolyn Leep Scholarship for professional development and the opportunity for outstanding high school seniors to apply for a \$10,000 scholarship to pursue a career in music education

A Community Well, a collaborative on-line group formed at the beginning of the pandemic, continued to encourage members to share information and experiences, request assistance, ask questions and network for the development of solutions and resources. Topics were organized for ease of use and submissions were accepted throughout the year.

An additional resource was developed by members to support teachers as they adapted to virtual, hybrid or continued with in-person learning. Exploring the MSVMA Rubric Through Remote Collaboration and Distance Learning included a 68-lesson curriculum centered around the performance rubric and featured a curriculum slide show. Each member-developed lesson offered teachers and students anticipated lesson outcomes, instructional tools and assessment options.

Summer Conference

July 29, 30 and 31

The Summer Conference Committee led by Director of Summer Conference Eric Cadena staffed by coordinators Helen Hansons and Amy Blevins responded effectively to the challenge of re-envisioning the 48th edition of this professional development activity to a virtual format. An online content delivery partner who offered the additional benefits of social and networking features was contracted, and presenters were identified. A team was organized to facilitate the live, real-time delivery of sessions. Tutorial videos and a mobile app were developed to assist members in accessing the Conference. These efforts proved to be effective as Conference attendance increased by 68%.

In keeping with the Conference's tradition, attendees accessed professional development sessions designed for vocal music educators of all levels. Participants were able to earn 25 hours of State Board Continuing Education Clock Hours (SCECH) certified programming which was an increase of 47%. By recording the sessions, the Conference content was accessible for a year and participants could complete them for credit at their convenience during this time period. Participation in this Conference option tripled with 64 teachers completing 270 SCECHs.

Headliner Dr. Amanda Quist, Director of Choral Activities of the Frost School of Music at the University of Miami delivered sessions live – Building Sound, Building Spirit, Seating the Choir and Authentic Leadership – Becoming Your Best Self on the Podium. VOCES8, a British vocal ensemble that tours globally performing an extensive repertory in its a cappella concerts and in collaborations with leading orchestras, conductors and soloists presented sessions – The VOCES8 Method and New Learning ideas in the Digital Age and Choral Questions with VOCES8. These session highlights were well received by Conference participants.

Recognizing the importance of technology in the pandemic teaching and learning environment, a core learning component of five sessions focusing on ways to use technology in the classroom was offered to Conference participants including:

- Exploring the MSVMA Rubric Through Remote Collaboration and Distance Learning
- Creating Virtual Choirs: An Introduction to Final Cut Pro
- Technology and Vocal Music
- ForScore & 7 years ago . . . iPad, Apple TV, and more in the Choral Rehearsal
- Voce Vista Resonance Imaging Software: Practical Applications for Teachers and Singers

Choral Student Leadership Conference

Plans are in place to offer this program when students may attend safely.

Carolyn E. Leep Scholarship

The Carolyn F. Leep Scholarship was established in 1988 in honor of Carolyn's service to the Michigan School Vocal Music Association. Scholarships are awarded to members who have at least three years teaching experience in Michigan and will be able to return to MSVMA activities after using the scholarship. Scholarship funding may be used to pursue an advanced degree or a non-degree choral music institute or workshop. Potential areas of study include choral conducting, composition, with emphasis on choral/vocal music, vocal music education and church music with vocal/choral emphasis. Applications, which may include an interview, are reviewed by the Carolyn F. Leep Scholarship Committee which is chaired by the past president.

The Committee selected two recipients. Anna Doering, the director of choirs at Bangor Township Schools, used her scholarship for tuition at Michigan State University as she pursues a master's degree in choral conducting. Caleb Sinclair used his scholarship for tuition at Oakland University where he also is pursuing a master's degree in choral conducting. He is the choir director and general music teacher at junior and senior high schools of Capac Community Schools.

Choral Music Education Scholarship

The Choral Music Education Scholarship was established this year and will annually be awarded to an outstanding high school senior from an MSVMA member school who will be pursuing a degree in choral music education at a Michigan college or university. The \$10,000 scholarship is divided over four years and the recipient must maintain a 3.0 GPA and remain in good standing in their program as a full-time student. The recipient was Fiona Breen who is studying at Michigan State University.

Clinician Consultant Program

This program offered member schools the option to bring a clinician/consultant into their classrooms to work with students and directors. Clinician/Consultants must be selected from a list maintained by MSVMA. Due to the nature of the delivery of this program, it was suspended for this school year.

Education Mini-Grant Program

Ten \$500 mini-grant annually are awarded to MSVMA member schools to support their annual music budget. Funds can be used for classroom items, music purchases, transportation, technology, uniforms, professional development, or innovative projects. The program suspended for the 2020-21 school year.

Honors Choirs

Honors Choirs

Honors Choirs which traditionally included 6-7-8-9, High School, All-State and All-State Vocal Jazz were adapted to the form of virtual choir performances. Virtual honors choirs for High School (SATB), Middle School (SATB), and Vocal Jazz were offered to students. A professional production company, Overneath Creative Collective, collected, edited, and produced each virtual choir. There was no audition process and all students 6-12th grade were encouraged to participate in their respective choirs. Students were urged to prepare by individual rehearsal and by attending Zoom rehearsals. All student submissions were included in the final virtual choir production.

Marques L. A. Garrett was selected to serve as the virtual High School Honors Choir Conductor. Dr. Garrett led the virtual rehearsals and helped students to navigate this performance option. A Virginia native, Dr. Garrett is an Assistant Professor of Music in Choral Activities at the University of Nebraska-Lincoln in the Glenn Korff School of Music. Before earning his Ph.D. in Music Education (Choral Conducting) at Florida State university, he was the Director of Choral Activities at Cheyney University of Pennsylvania. Additionally, he holds an MM from the University of North Carolina at Greensboro and a BA from Hampton University. An active conductor, Dr. Garrett serves as a guest conductor or clinician with school, church, community and festival/honors choirs throughout the country. In addition to his conducting classes at UNL, he leads conducting workshops at other universities and conferences. A versatile voice that performs both as a baritone and countertenor, Dr. Garrett has sung with several community, church and university groups as a chorister and soloist. He is an avid composer of choral and solo-vocal music whose compositions have been performed to acclaim by high school all-state, collegiate and professional choirs. GIA Publications, Walton Music, Santa Barbara Music Publishing, Hinshaw Music, G. Schirmer, Beckenhorst Press and Carus-Verlag have published several of his compositions. As a researcher, his most advantageous topic is the non-idiomatic choral music of black composers. Dr. Garrett lectures at state and regional conferences of the American Choral Directors Association and at other local and national venues affording him the opportunity to showcase this underrepresented area of music. He holds membership in the American Choral Directors Association, American Society of Composers, Authors and Publishers, National Collegiate Choral Organization and Pi Kappa Lambda. With the National Association of Negro Musicians, he currently serves as the national scholarship chair.

MSVMA members Greg Cleveland and April Tini conducted the Middle School Honors Choir and the Vocal Jazz Honors Choir respectively. Mr. Cleveland retired from Walled Lake Consolidated Schools as its Director of Vocal Music and Musical Theater. He has been honored by MSVMA with member emeritus status and continues to serve the organization in a variety of roles including as a member of its Adjudication Committee. April Arabian-Tini retired from Orchard Lake Middle School/West Bloomfield Middle School as a vocal music teacher. Ms. Arabian-Tini is a vocal music educator, solo artist, composer/arranger, adjudicator and clinician who has conducted all-state and regional choirs. The 2021 Honors Choirs performances were previewed by MSVMA membership at its Virtual Annual Meeting on January 29, 2021.The public premiere on YouTube and social media followed the meeting. The debut of these innovative projects celebrated the hard work of hundreds of young Michigan singers.

Specialized Festivals

Musical Theatre Intensive

MSVMA welcomed 100 singers in grades 9-12 to our Musical Theatre Intensive on Saturday, October 24 via a virtual event. A panel of respected clinicians led by Catherine A. Walker from the University of Michigan conducted the Intensive. Students had the opportunity to sing for clinicians in a Master Class format and participate in a variety of topic sessions. Festival Supervisor Lyn CieChanski, Director of Vocal Music at Skyline High School and Festival Coordinator Kathryn Witkoski, vocal music student at Central Michigan University served as event facilitators.

Musical Theatre Solo & Ensemble Festival

Traditionally two Festivals – East and West – this event was offered as a virtual event to all students 7-12th grades to participate as soloists or in ensembles to receive a Final Determination or comments only. Following the completion of the online registration by their director, students submitted a video of their performance for adjudication. Adjudicators completed the rubric which was then provided to the participant's director for review and discussion with student(s).

Virtual Solo and Ensemble Festival

Traditionally conducted at the District and State level, these Festivals were combined. Students 6-12th grades were encouraged to participate as soloists or in ensembles to receive a Final Determination or comments only. Following director registration of students at reduced fees, participants uploaded a video performance for adjudication. An adaption of adjudication process provided folders of videos for adjudicators to review and complete a rubric for each performance. Completed rubrics were provided to teachers for distribution to the participants. This adapted festival format enabled 764 students and their teachers to continue to develop their knowledge of vocal music.

Virtual Choral Festival

MSVMA traditionally provides a tiered Choral Festival opportunity to its members through participation in District Festivals with those earning a Final Determination of Excellent able to move forward to the regionally organized State Choral Festivals. Offering a Choral Festival experience required adaptation of this model including modifying the requirement of a choir requiring 17 or more students as well as changing the adjudication outcome to Comments Only with adjudicators naming the best choirs to participate in the Virtual Michigan Youth Arts Festival.

Large ensembles comprised of 6 to 20 singers were encouraged to participate in the virtual Choral Festival. As for the Solo and Ensemble Festival, fees were reduced, and participation was via video submission. Adjudicators were provided with folders of choral performance videos and offered their feedback via the organization's rubric. Despite the challenges of gathering for choir rehearsals and the changing status of school attendance in response to pandemic, 228 choirs participated in the Choral Festival.



16th Annual Michigan Music Conference

Conducted as a virtual event, MSVMA members enjoyed presentations from colleagues and national headliner, Dr. Joe Miller, Director of Choral Studies at the University of Cincinnati's College Conservatory of Music. The Conference included live Q&A sessions, on-demand offerings to maximize State Board Continuing Education Clock Hours (SCECH) options, virtual exhibit showcasing partnering vendors, celebrations of MSVMA members and our colleagues during social times, the first music college fair and the opportunity to view any of the MMC interest sessions following the Conference at participant's convenience.

The headliner sessions included:

Introduction to Why

When we conduct, we teach, we listen, we change. The process of questioning builds our imagination, and this world of images, sounds, and ideas is the stuff that great teaching is made of.

Transforming Space

Examine your own experience with sound and space and take a virtual site-visit to explore some creative ideas. Can we find new ways to connect with new audiences? Finding a way to join mission, space, and sound can be an exciting new chapter in the musical development of you and your students.

Building Voice Through Community

If the choral art is to continue being a vital part of our culture, we must focus on ways to respond to current society. What does it take to reach a modern audience? We must find ways to resonate with our changing community that promote and celebrate our deep musical heritage, advancing new voices and connecting to the human experience. We will explore new ideas in programming and audience engagement.

Sarah Stockton 2021 Teacher of the Year

Sarah Stockton is the Vocal Music Director at Walled Lake Western High School. She directs 4 curricular choirs and 2 extra-curricular ensembles, as well as the all-school musical. Before joining WLW in 2018, Mrs. Stockton was the Vocal Music Director at Grand Blanc High School since 2006 and choir teacher at Grand Blanc West Middle School since 2009. She holds a Master of Music in Choral Conducting from Michigan State University, studying under Dr. David Rayl and Dr. Jonathan Reed, and a Bachelor of Music Education from Central Michigan University. Her mentor, Dr. Nina Nash-Robertson (CMU) passed away in 2018 but has made a lasting impact on her teaching.

Sarah's choirs regularly perform and excel in Michigan Schools Vocal Music Association's Solo and Ensemble and Choral Festivals, and she currently serves as an adjudicator and curriculum coordinator. She has been a Summer Conference presenter and has served as the District 4 Manager. Additionally, Mrs. Stockton was selected as the 2020 6-7-8 SA Honors Choir director. Mrs. Stockton was previously the Artistic Director for the New Century Chorale, an adult community choir in the Grand Blanc area from 2009-2018. She served as a frequent soprano soloist and guest conductor in the Flint community, as well taught private voice and piano lessons.

In 2018, Sarah was honored to become a choral staff member for the Michigan Ambassadors of Music. She traveled to England, France, Switzerland, Austria, Italy, Liechtenstein and Germany during the summer of 2019. Mrs. Stockton was a 2016 and 2017 Chairman's Award Nominee for Educator of the Year by the Grand Blanc Chamber of Commerce.

She resides in Farmington Hills with her husband, Josh and their son Everett. They have two dogs, Kofax and Peanut. In her free time, she enjoys creating resources for her Teachers Pay Teachers store, gardening, and crafting.

MSVMA Receives Michigan Council for the Arts and Cultural Affairs Grant

MSVMA was pleased to recognize the support of Michigan Council for the Arts and Cultural Affairs (MCACA) and the National Endowment for the Arts by adding organizational logos to its website home page and other promotional materials. The \$15,000 grant will support programming around the state as well as key initiatives including the Student Leadership Conference, Summer Conference and the creation of a new Volunteer Retreat to provide in-person training, planning and communications. MCACA used a peer review process over a 30-day period of panel reviews to evaluate the grant applications and made recommendations to its Governor's Council. The applications were evaluated by 153 peer reviewers during the open panel process with nearly 500 interested members of the public attending the panels on-line.


